### 3. Pedestrian Signage Project update

Cornwall Council Highways Department has granted permission for the signs on the highways. Coodes Solicitors have been instructed to draft a contract between St Ives BID and Town Council stating the BID is responsible for ownership, insurance and ongoing maintenance of the signs, but if the BID does not get renewed in May 2019 the town council will take over.
