Coming out of Lock Down

This year BID took on a very different role to previous years, as did the whole world in response to COVID 19 and all the challenges it brought.

Of primary importance was to share information as and when it was available to all Levy Payers pertaining to businesses, government guidelines and COVID generally, virtually on a daily basis. Meetings with our MP, Cornwall Council, Town Council, and South West Bid Managers to ensure all information available at any one time was shared with Levy Payers Bid also at the start of lock-down played a part together with a number of other groups in supporting the community as a whole, sharing the towns newsletters of what was available and where to get help, then to ensure that they were distributed that to every household in the parish. BID supported businesses reopening with signage, getting advice, help with grant applications, and generally staying in touch on regular basis for welfare and well-being of Levy payers in difficult circumstances.

Pedestrianisation Scheme

St Ives BID have submitted an expression of interest through the Town Deal Committee. The success of this summer's Pedestrianisation trial in response to assisting social distancing measures has shown how beneficial having such a scheme in place could be going forward. This would aide in future summers, events that require road closures such as the New Years Eve Fireworks, and greatly help in easing the obstacles faced by Emergency Services due to the narrow, and busy nature of St Ives streets.





St Ives Branch Works

This winter GWR are going to be carrying out another round of improvements to the St Ives Branch-line. The 5 weeks of work is set to be carried out during January and February 2021. It is scheduled to be completed by Sunday the 7th of February.

This work involves replacing the length of line between Carbis Bay and St Ives. This is to be carried out in order to allow GWR to run more modern faster trains on the line in the future.

Winter Planting

The summer planting this year helped make a beautiful welcome to St Ives for residents and visitors alike. Now with the season changing, we are moving towards the winter flower project, which is plant scape units placed in various locations throughout the town, including Trewyn Gardens, Memorial Gardens and The Malakoff flower bed and wall.

All unit beds will be planted will have various winter plants and a selection of bulbs to keep the town looking beautiful during winter.

Rightmove's 2020 study, with over 21,000 respondents, found that coastal areas stand out amongst the pack when it comes to residents feeling happy about where they live.

Our idyllic coastal town, with its picturesque beaches and vast spaces, has always been a draw to holidaymakers, indicated by the swelling numbers come summertime, but it's the residents themselves that have been most appreciative of St Ives this year. This year's lock-down period allowed for only one hour of exercise, but the people of St Ives found that they could make the most of it by getting out and enjoying the numerous walks and activities that the town has become known for.

The results also showed that our neighbours were considered to be the friendliest in the UK. This year has shown that, as a community, we come together during times of adversity to support the town and those most vulnerable. This very neighbourly spirit also prompted a record number of volunteers in our community, from making regular calls to check in on people to delivering food and medicine for those who may not have had a wider support network around them during a time when it was needed most.

With social distancing and lock-down measures, it is easy for people to become lonely through isolation, especially those at greater risk from corona-virus. St Ives may be known for its touristic reputation, but it is its community spirit that has highlighted why it is such a happy place to live.

If you do not form a Christmas bubble, you should continue to follow the guidelines for the tier in your area. You may still meet with your support bubble or childcare bubble.

From 28th December

You must follow the guidelines for the tier in your area. Christmas bubbles will no longer apply.

The logo will be the most visible element of the St Ives brand. Its usage must be clear and consistent at all times.


Space:
